General Information

BRANDT DISPERSE enhances the performance and consistency of pre-emergent herbicides when chemical incompatibilities create difficult tank mix situations and incomplete herbicide dispersion.

Directions for Use

APPLICATION RATE: 1 to 3 fl. oz. per acre.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total required water volume and/or UAN in tank. Add BRANDT DISPERSE and agitate until thoroughly mixed. Add pesticide(s) and other agrichemicals and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is a good field practice for evaluating compatibility of multiple chemical mixtures.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in original container away from children, animals, foods, feeds and seeds. Handle in accordance with Precautionary Statements. In the event of spills or leaks, soak up the material with absorbent clay, sand, sawdust or other absorbent material. Scrape up and dispose in accordance with Product Disposal.

PRODUCT DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
