## DIRECTIONS FOR USE

BRANDT NO FOAM B is an APE-free, non-ionic surfactant blend designed to increase the efficiency of fungicide, herbicide and insecticide applications by providing exceptional wetting and uniform coverage. Spray solutions sensitive to alkaline hydrolysis benefit from its acidifying and buffering properties. This product may be used on agricultural, forestry, turf and ornamental, industrial, structural and non-cropland sites.

Read and follow the precautions, restrictions and recommendations on the labels of herbicides and insecticides used with BRANDT NO FOAM B. Use according to the most restrictive label directions for each product in any tank mix.

**COMPATIBILITY:** BRANDT NO FOAM B is compatible with most listed pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

**MIXING:** Shake well before using. Fill spray tank 1/2 full of water and begin agitation. Add the recommended amount of BRANDT NO FOAM B. Add herbicides and insecticides as directed by label or in the following sequence and continue filling tank: (1) Dry flowables or water dispersing granules, (2) Wettable powders, (3) Flowables, (4) Solutions, (5) Emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.

**RECOMMENDATIONS:** Rate to use will vary depending on the type of foliage to wet, the desired pH of the spray tank solution, volume per acre, and chosen application equipment. Higher rates than those below may be used if recommended by fungicide, insecticide, or herbicide labeling. Follow pesticide label directions. However, do not add this product at a rate which exceeds 5% of the finished spray volume.

**Air or Ground:** Use ½-3 pints per 100 gallons of finished spray solution. For improved efficacy, use at least ½ pint per acre when finished spray volume is less than 20 gallons per acre. For backpack or hand held sprayers, use 1 fl. oz. per gallon of finished spray solution.
