Rate Recommendations

Foliar Application

Ground: Apply 1 to 4 quarts in a minimum of 10 gallons of water per acre and repeat as needed.

Aerial: Apply 1 to 4 pints in a minimum of 5 gallons of water per acre and repeat as needed.

Soil Application

Use 1 to 6 quarts per acres. Do not use or mix with starter fertilizer.

Optimum rate of application will vary depending on treatment interval, soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and its nutrient requirements. For best results, follow soil/tissue test recommendation.

Mixing and Handling Instructions

CAUTION when mixing with glyphosate based herbicides.

If you apply with glyphosate, AMS and an acidifying adjuvant is recommended. Fill with $\frac{1}{3}$ to $\frac{2}{3}$ of total required water volume in tank. Add adjuvants, fertilizers, and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of this product and agitate until thoroughly mixed. Check chemical mixture compatibility using a jar test prior to application, especially for high phosphate and alkaline (high pH) solutions.
