General Information

BRANDT SMART K B is specifically formulated for foliar delivery of potassium, boron and molybdenum. The boron formulated in BRANDT SMART K B is up to 8X more mobile and efficient than standard 10% boron sources.

Rate Recommendations

Field, Row, Vegetable, Fruit Tree and Vine Crops: Apply 2-5 L per hectare per application throughout the growing season. More frequent applications at 1 L per hectare on row crops and 2 L per hectare on fruit and vegetable crops may be needed to correct deficiencies once they occur.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and general health. For optimum results, follow soil/tissue test recommendation.

Mixing and Handling Instructions

Fill mix tank with half of required water volume and begin agitation. Add products in this order, mixing thoroughly after each addition: adjuvants, pesticides, and last, fertilizers. Fill tank with remainder of water and continue agitation until solution is completely mixed. Check chemical mixture compatibility using a jar test prior to application.
