BRANDT NOCULATE 8-21-5 is a high phosphate blended greens grade starter complex for establishing seed, sod or seeking denser and deeper root systems of established turf. This product supplies Fe in the sucrate form, which provides both immediate and delayed availability of this nutrient. This product also features humic acid, surfactant and microbes.

Directions for Use on Professional Turf

Greens, Tees & Fairways - Broadcast at the following rates:

To deliver 1/3 lb of nitrogen per 1000 sq ft, apply 4.8 lb of product per 1000 sq ft.

To deliver 1 lb of phosphate per 1000 sq ft, apply 4.8 lb of product per 1000 sq ft.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn/garden, and sweep any product that lands on the driveway, sidewalk, or street, back onto your lawn/garden. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices.
