General Information

BRANDT MANNI-PLEX ROOT BUILDER is designed for application to all field, row, vegetable, fruit, tree and vine crops, and turf and ornamentals for the prevention and correction of micronutrient deficiencies when used as part of a balanced fertility program.

Rate Recommendations

Field, Row, Vegetable, Fruit, Tree and Vine Crops: Apply 1-2 guarts per acre per application throughout the growing season. At least 3 applications are recommended. More frequent applications at 1.5 guarts per acre may be needed to correct deficiencies once they occur. For pre-plant or sidedress applications, use 1-2 gallons per acre.

For professional use, apply every 7-14 days, as needed.

Fine Turf (Warm or Cool Season Turfgrasses) Putting Greens and Tees

Maintenance: 3-6 fl. oz. per 1,000 sq ft or 1-2 gallons per acre.

Fairways, Sports Turf and Lawns

Maintenance: 6-9 fl. oz. per 1,000 sq ft or 2-3 gallons per acre.

Renovation: 6-9 fl. oz. per 1000 sq ft or 2-3 gallons per acre.

Overseeding: 3-6 fl. oz. per 1,000 sq ft or 1-2 gallons per acre, applied every 7-14 days after germination and plants have reached the 3 tiller phase. Most effective when used as part of an overall overseeding nutritional program.

Foliar Application

Apply a foliar spray early in the morning or late in the day for best results. Allow foliar sprays to dry thoroughly before irrigation to insure even foliar uptake.

Ornamental Plants: Apply 1-2 fl. oz. per 1 gallon of water as a foliar spray.
