Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Following product recovery, flush area with water.</p> <p>Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.</p> <p>Never return spills to original containers for re-use. Minimize dust generation and accumulation. Prevent entry into waterways, sewer, basements or confined areas. For waste disposal, see section 13 of the SDS.</p>
