HAZARDS TO HUMANS AND DOMESTIC ANIMALS: Causes skin irritation and serious eye irritation. Wear protective eyewear and gloves when mixing or handling concentrate. DIRECTIONS FOR USE

Read the entire label before using this product. Use only according to label instructions.

BRANDT NEO-TEC S.O. is a naturally derived nematicide for the control of parasitic nematodes on turf grasses, golf courses, sports fields, and recreational turf.

CAUTION: Although BRANDT NEO-TEC S.O. has been found to be extremely safe, the risk of phytotoxicity is the highest in the late afternoon or evening, particularly in warmer weather. BRANDT NEO-TEC S.O. contains high concentrations of sesame oil, which is highly toxic to nematodes. Do not apply to areas where beneficial nematodes have been recently introduced.

MIXING

Shake well before using. Fill spray tank ½ full of water and begin agitation. Add the recommended amount of BRANDT NEO-TEC S.O. Add products as directed by label or in the following sequence and continue filling tank: (1) Dry flowables or water dispersing granules, (2) Wettable powders, (3) Flowables, (4) Solutions, (5) Emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.

Turf grasses, Golf courses, Sports fields, Recreational turf or home lawns Neo-Tec S.O. is safe to use on newly seeded lawns and established lawns of Bentgrass, Ryegrass, Fescues, Bluegrass, and warm season grasses, including Bermudagrass, Zoysia, St. Augustine, and others.

APPLICATION RATES

Start applications in early spring (approximately one month before growing season) and continue until late fall (approximately one month after growing season). Apply with a minimum of 1/2 gallon of water per 1000 sq. ft. (20 gals/ acre) so that uniform distribution is achieved in the soil profile. One irrigation head rotation is sufficient to water-in and to remove remaining product from blades.

Do not irrigate turf until the evening after treatment. Do not apply NEO-TEC S.O. when the soil has become saturated with water or when rain is expected on the day of treatment.

Initial Application Rate

Apply 3 - 3.5 fl. oz. per 1000 sq. ft. If treatment program is started in the middle of the growing season, make a single initial application at 6 - 7 fl. oz. per 1000 sq. ft.

Maintenance Application Rate

Monthly applications of 3 - 3.5 fl. oz. per 1000 sq. ft. Additional applications can be made as needed if heavy nematode infestation is present, heavy or persistent rainfalls occur, or during heavy irrigation cycles with soil wetter/surfactant chemistries are being applied.
