GENERAL INFORMATION

BRANDT ADJULOCK PRIME is a volatility and drift reduction adjuvant which is designed for use in dicamba tolerant cropping systems. The product should be used along with approved nozzle and pressure combinations sufficient to generate an Ultra-Course droplet spectrum and suitable spray pattern.

BRANDT ADJULOCK PRIME uses a specially balanced buffering and volatility control system to reduce the volatility of dicamba and dicamba containing tank mixes.

BRANDT ADJULOCK PRIME provides ammonium free water conditioning and wetting which meets the label requirements for mixing with approved dicamba products to be applied on dicamba tolerant crops.

DIRECTIONS FOR USE

Prior to use, read all the directions on this label and on the label of all pesticides, fertilizers, and any other tank mix additives. Do not use unless a nonionic surfactant (NIS), water conditioner, drift reduction technology (DRT) and deposition agent are allowed or not excluded on the label. When using along with dicamba in dicamba tolerant crops review the website associated with the relevant dicamba containing product for any additional tank mix instructions.

COMPATIBILITY: BRANDT ADJULOCK PRIME is compatible with most water-soluble, emulsifiable concentrate, suspension concentrate, water dispersible granule, and wettable powder pesticides when applied by aerial or ground equipment. However, if the desired combination or order of addition has not been previously used, a compatibility test is recommended. Refer to the individual websites for Engenia®, FeXapanTM, and Xtendimax[®] for approved tank mix partners.

MIXING: To a clean spray tank add sufficient clean water to reach at least ½ full. Be sure to agitate the tank during mixing and application. With agitation, add BRANDT ADJULOCK PRIME to the spray tank prior to adding the pesticide(s) and other adjuvants. Finish with remaining water and maintain agitation until thoroughly mixed. Be sure to allow sufficient time for mixing prior to application. When using a tank mix for the first time, prepare a jar test to assess the mixture for compatibility.

RATES: Use BRANDT ADJULOCK PRIME at 4 quarts per 100 gal spray mixture or 1.0% v/v.
