General Information

Application Instructions

This product can be applied any time during the crop cycle, from planting to harvest.

Foliar Applications: Apply 1-4 quarts per 10-100 gallons of water per acre throughout the growing season.

Fertigation: Apply through irrigation systems at a rate of 1–2 gallons per acre.

Mixing and Handling Instructions

SHAKE WELL. For foliar applications, Fill mix tank with half of required water volume and begin agitation. Add products in this order, mixing thoroughly after each addition: adjuvants, pesticides, then fertilizers. Fill tank with remainder of water and continue agitation until solution is completely mixed. Check chemical mixture compatibility using a jar test prior to application.

For injection into fertigation, drip lines or mixing with concentrates, perform a jar test to evaluate compatibility with chemical mixtures. This product has shown good compatibility with many fertilizer blends including 4-0-8, phosphoric acid, UAN solutions, and micronutrients, including calcium and magnesium solutions. Tank mixtures should be used in a timely manner. Do not mix with 10-34-0 or 11-37-0.
