Vacuum and Feedcup Meters:

Add 1.5 to 2.0 oz (approx. ¼ cup) of BRANDT SeedFlow Zn per 80,000 seeds. Increase rate for treated seed and high humidity conditions. Shake well before using. Ensure the lid is secure before shaking.
