This product features the elements Fe, Mn and Mg in the sucrate form, which provides both immediate and delayed availability of these nutrients. This product also features dolomite, which helps soil pH.

Directions for Use on Professional Turf

Greens, Tees & Fairways - Broadcast at the following rates:

To deliver 0.5 lb of nitrogen and potassium per 1000 sq ft, apply 3.8 lb of product per 1000 sq ft.

To deliver 1 lb of nitrogen and potassium per 1000 sq ft, apply 7.7 lb of product per 1000 sq ft.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn/garden, and sweep any product that lands on the driveway, sidewalk, or street, back onto your lawn/garden. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices.
