General Information

BRANDT MANNI-PLEX Fe is specifically formulated for enhanced delivery of iron.

Rate Recommendations

Horticultural and Broadacre Row Crops

Apply 1 to 3 litres of BRANDT MANNI-PLEX Fe as a foliar application per hectare throughout the growing season. Multiple applications may be needed to correct deficiencies once they occur. Use a minimum of 100 litres of water per hectare per application.

Fruit/Nut Trees and Vine Crops

Apply 3 to 6 litres of BRANDT MANNI-PLEX Fe as a foliar application per hectare throughout the growing season. Multiple applications may be needed to correct deficiencies once they occur. Use a sufficient amount of water to ensure adequate coverage. Coverage should occur to just prior to the point of run-off.

Aerial Application

Use a minimum of 30 litres per hectare total volume; use the lower foliar rate as a guide for aerial application.

Optimum rate of application will vary depending on your soil properties such as soil pH, organic matter content, soil texture, weather conditions, time of year, general crop health and species. For best results, follow soil test or plant analysis recommendation.

Mixing Instructions

Put 1/3 to 2/3 of total desired water volume in tank. Add adjuvant(s) if desired and agitate until thoroughly mixed. Add pesticide(s) if desired and agitate until thoroughly mixed. Add desired amount of BRANDT MANNI-PLEX Fe and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is a good field practice for evaluating compatibility of multiple chemical mixtures. Caution: Check compatibility with chemical mixtures, high phosphate and alkaline (high pH) solutions.

Compatibility

BRANDT MANNI-PLEX Fe may effectively be applied with many agricultural chemicals. For unfamiliar tank mix combinations sufficient evaluation to determine efficacy and crop safety may be warranted. Avoid tank mixing with phosphate and/or excessively alkaline based fertilizer solutions.
