### General Information

BRANDT 11-8-5 provides highly available plant food for foliar feeding and is compatible with most pesticides for combination spraying. It is primarily intended to stimulate early season plant growth. Follow recommendation of local agricultural authorities for specific rates and timing.

### Rate Recommendations

**Field, Row, Vegetable Crops:** Apply 1-2 quarts per acre in at least 20 gallons water per acre for ground sprayers or 3 gallons for aircraft. Repeat as needed.

**Fruit, Tree and Vine Crops:** Apply 2 quarts per acre in at least 100 gallons water per acre with conventional sprayers, 40-100 gallons with concentrate sprayers, or 10 gallons for aircraft. Repeat as needed. On waxy foliage or smooth skinned fruit, add sufficient spreader for smooth wetting to avoid spotting.

**Turf (For Professional Use Only) and Ornamentals:** Apply 1-2 quarts per acre (0.75-1.5 fluid ounces per 1,000 square feet) in sufficient water for thorough coverage. Repeat as needed.

Optimum rate of application will vary depending on treatment interval, soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and its nutrient requirements. For best results, follow soil/tissue test recommendation.

### Mixing and Handling Instructions

Fill mix tank with half of required water volume and begin agitation. Add products in this order, mixing thoroughly after each addition: adjuvants, pesticides, then fertilizers. Fill tank with remainder of water and continue agitation until solution is completely mixed. Check chemical mixture compatibility using a jar test prior to application. Make test applications on a few plants if using combinations not known to be safe. To avoid phytotoxicity, do not apply with copper or lime-sulfur fungicides, or during bloom.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn/garden. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices.

In Virginia, this lawn fertilizer, which contains phosphorus, is intended only for nonagricultural use on (i) turf during its first growing season, (ii) turf areas being repaired or renovated, and (iii) turf where a soil test performed within the last 3 years indicates a phosphorus deficiency. This fertilizer is not intended for the routine maintenance of turf.
