## General Information

MANNI-PLEX GROW is designed for turf application for the prevention and correction of micronutrient deficiencies when used as part of a balanced fertility program.

## Rate Recommendations

**Turf:** For professional use only, apply to actively growing turf. For best results apply early morning or late evening.

**Green & Tees:** 3-8 fluid ounces per 1,000 square feet.

**Fairways & Sports Turf:** 1-2.5 gallons per acre.

**Overseeding:** 3 fluid ounces per 1,000 square feet after germination.

**Sod Installation:** 3 fluid ounces per 1,000 square feet at installation.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general plant species and health. For best results, follow soil/tissue test recommendation.

## Mixing and Handling Instructions

Fill mix tank with half of required water volume and begin agitation. Add products in this order, mixing thoroughly after each addition: adjuvants, pesticides, then fertilizers. Fill tank with remainder of water and continue agitation until solution is completely mixed. Check chemical mixture compatibility using a jar test prior to application.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rains are expected. Apply this product only to your lawn/garden. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices.
