GENERAL INFORMATION

BRANDT UPTAKE NIS 90 is a blend of nonionic surfactants and super wetting organo-siloxane surfactants that provide superior spreading and dramatically reduces surface tension in spray solutions resulting in improved wetting of leaves and other parts of plants. This product also improves uptake through penetration of cuticular waxes and stomatal flooding.

DIRECTIONS FOR USE

1-2 quarts per 100 gallons of water. Read and follow the precautions, restrictions, and recommendations on the labels for pesticides used with this product. Use according to the most restrictive label directions for each product in any tank mix. This product may be used on agricultural, forestry, turf and ornamental and non-crop land sites.

COMPATIBILITY: This product is compatible with most pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

MIXING: Fill spray tank half full of water and begin agitation. Add pesticides as directed by label or in the following sequence and continue filling tank: (1) Dry flowables or water dispersing granules, (2) Wettable powders, (3) Flowables, (4) Solutions, (5) Emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Add the recommended amount of this product. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application
