GENERAL INFORMATION

BRANDT UPTAKE HS MSO is a highly effective blend of methylated seed oil (60%) and quality nonionic surfactants (40%). It is designed for use with pesticides when a combination of oil and surfactant is required or preferred. Because of the concentrated surfactant load, this product can be used at lower rates than traditional oils without sacrificing performance and effectiveness. This product's unique technology increases droplet spreading, cuticle penetration, and has humectant properties that resist evaporation for increased deposition. This product utilizes a low foam technology, has enhanced crop safety and is NPE/APE free.

DIRECTIONS FOR USE

Ground, Aerial, Low volume, CDA:

COMPATIBILITY: This product is compatible with most pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

MIXING: Fill spray tank half full of water and begin agitation. Add pesticides as directed by label or in the following sequence and continue filling tank: (1) Dry flowables or water dispersing granules, (2) Wettable powders, (3) Flowables, (4) Solutions, (5) Emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Add the recommended amount of this product. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.
