### GENERAL INFORMATION

BRANDT UPTAKE COC is a combination of surfactant and a superior paraffinic oil designed for use in crop protection spray programs. This product increases the effectiveness of pesticides. will increase the activity of pesticides and enhance performance. Therefore, care must be taken in treating crops during periods when plants are subjected to drought stress, high temperatures and high humidity.

#### DIRECTIONS FOR USE

**AIR or GROUND:** Use 1-4 pints per 15-100 gallons of finished spray solution. For improved efficacy, use at least 1 pint per acre when finished spray volume is less than 20 gallons per acre. For backpack or hand held sprayers, use 1 fluid ounce per gallon of finished spray solution.

Follow pesticide label directions. However, do not add this product at a rate which exceeds 5% of the finished spray volume, except when used as a diluent for basal bark applications of herbicides. This product may be used on agricultural, forestry, turf and ornamental, and non-cropland sites.

**COMPATIBILITY:** This product is compatible with most pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

MIXING: Fill spray tank hlaf full of water and begin agitation. Add pesticides as directed by label or in the following sequence and continue filling tank: (1) Dry flowables or water dispersing granules, (2) Wettable powders, (3) Flowables, (4) Solutions, (5) Emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Add the recommended amount of this product. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.
