GENERAL INFORMATION

BRANDT UPTAKE PLUS is a convenient-to-use low foaming premix of ammonium sulfate, nonionic surfactant, dispersant and sugar release technology to help condition hard water and drive herbicide uptake and translocation. This product helps improve weed control with glyphosate and glufosinate applications by conditioning water in the tank mix. Sugar Release Technology increases uptake and translocation of herbicide to increase performance.

DIRECTIONS FOR USE

This product may be used at a rate of 1.25-5.0% v/v. 2.5-5.0 gallons per 100 gallons of spray solution. Follow herbicide label for specific rates, mixing instructions and other precautionary instructions.

This product provides:

- 2.8 pounds of dry ammonium sulfate per gallon.
- 1 pint of nonionic surfactant in a 1.25 gallon per 100 use rate.

COMPATIBILITY: This product is compatible with most pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

MIXING: Fill spray tank half full of water and begin agitation. Add pesticides as directed by label or in the following sequence and continue filling tank: (1) dry flowables or water dispersing granules, (2) wettable powders, (3) flowables, (4) solutions, (5) emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Add the recommended amount of this product. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.
