A proprietary blend of 58 strains of aerobic and facultative beneficial bacteria @ a minimum concentration of 10×10^7 CFU/gram (including *Bacillus subtilis*).

General Information

BRANDT AQUA BIO-TROL SS is the safe, natural way to establish and maintain cleaner pond and lake water without chemicals. This product eliminates pond scum and green, soupy conditions, while eliminating foul odors. This product will improve water clarity and digest excess organic matter in ponds, lakes and fountains.

This product is a microbial system formulated to expedite the establishment of beneficial microbial populations in aquatic environments. This biologically diverse formulation contains 58 strains of select aerobic and facultative bacteria capable of biodegrading cellulose, lignin, hydrocarbons and other organic contaminants in ponds, lakes and aquaculture settings. Many of the strains also serve to reduce excess nitrates and phosphates from the water column. Typically, you will see an improvement in water clarity within 2 weeks of implementing the program, provided adequate dissolved oxygen levels are maintained.

This product provides two times the active beneficial bacterial colonies per pound, compared to the granular form.

Directions for Use

BRANDT AQUA BIO-TROL SS pucks are most effective when water temperatures range from 50° to 100°F. For best results, provide adequate surface or subsurface aeration.

First Application

Use 14-16 BRANDT AQUA BIO-TROL SS pucks per acre/foot of water. Apply by distributing pucks as much as possible around pond and lake edges. Avoid dumping pucks in one concentrated location.

Subsequent Applications

Use 8 BRANDT AQUA BIO-TROL SS pucks per acre/foot of water once a month or as needed.
