DIRECTIONS FOR USE

RECOMMENDATION: Shake well before use. For general use as a DRA 1.0-1.5% v/v. When spraying Engenia®: 1.5% v/v. Noter This product has demonstrated excellent plant safety; however, not all species and varieties have been tested. Before treating a large area, treat a small area and observe prior to full scale application.

COMPATIBILITY: This product is compatible with most pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

MIXING: Fill spray tank half full of water and begin agitation. Add pesticides as directed by label or in the following sequence and continue filling tank: (1) Dry flowables or water dispersing granules, (2) Wettable powders, (3) Flowables, (4) Solutions, (5) Emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Add the recommended amount of this product. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.
