## GENERAL INFORMATION

BRANDT UPTAKE VRA, a VaporGrip® Xtra Agent may be used as an additional tool to reduce volatility potential when tank mixed with herbicide products containing dicamba. Use of BRANDT UPTAKE VRA, a VaporGrip® Xtra Agent does not replace a drift reduction adjuvant (DRA).

## DIRECTIONS FOR USE

This product is a volatility reducing agent but does NOT fully eliminate all volatility potential. This product does NOT control drift. Always follow the precautions, restrictions, recommended use rates, and application directions appearing on the labels for each product to be tank mixed. While the carrier is agitating, add BRANDT UPTAKE VRA, a VaporGrip® Xtra Agent to the spray tank first during the mixing and filling process.

**USE INSTRUCTIONS:** Use BRANDT UPTAKE VRA, a VaporGrip® Xtra Agent with approved dicamba herbicides for use in dicamba-tolerant soybeans and cotton as directed on the applicable product label. Use at a rate of 40 fluid ounces per acre (40 fl oz/A). Always follow all other requirements on the approved dicamba product label.
