

# Brandt AMS

For Use as a Water Conditioner

## General Information

BRANDT AMS is a quality ammonium sulfate solution designed to be used as a water conditioner. Always consult specific additive label and follow all use directions.

## Directions for Use

See specific additive label for use rates of BRANDT AMS. For labels reading: 8.5-17 lbs. (3.85-7.7 kgs) per 100 gallons (378 L) of spray solution, add 2.5-5 gallons (9.46-18.92 L) of BRANDT AMS. For labels reading: 2.5 lbs./acre (2.8 kgs/Ha), add 3 quarts/acre (7 L/Ha) of AMS. May be tank mixed with other adjuvants.

## Directions for Mixing

Agitate the tank water while adding BRANDT AMS. Add BRANDT AMS before adding additional adjuvants and pesticides. Add remaining additives to the tank.

## FIRST AID
