Foliar Micronutrient Supplement

General Information

BRANDT CITRUS PLUS is specifically formulated for foliar delivery of Iron, Manganese and Zinc. BRANDT CITRUS PLUS has shown excellent compatibility and efficacy with chemicals utilized on citrus crops including, but not limited to phosphites, NPK fertilizers, slow release nitrogen, thiosulfates, copper fungicides, microbials and insecticides.

Foliar Application

Use 2-6 quarts BRANDT CITRUS PLUS per acre in sufficient water for thorough coverage. More frequent applications at 2 quarts per acre may be needed to correct deficiencies once they occur.

Aerial Application

Use 1-2 quarts BRANDT CITRUS PLUS per acre with at least 5 gallons of water. Multiple applications are recommended for best results.

The use of an adjuvant may be desired to reduce the surface tension of the spray solutions. Performing trials with adjuvants may be useful in determining the best inclusion rates for optimal performance. Optimum rate of application will vary between fields, depending on soil pH and organic matter content. For best results, follow soil test or plant analysis recommendation.

Mixing Instructions

Put 1/3 to 2/3 of total desired water volume in tank. Add adjuvant(s) and pesticide(s) if desired and agitate until thoroughly mixed. Add desired amount of BRANDT CITRUS PLUS and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is a good field practice for evaluating compatibility of multiple chemical mixtures.

Weight per gallon: approx 10.8 lbs @ 65°F

Freezing temperature: 32°F
