DIRECTIONS FOR USE

BRANDT SAF-T-FOLIAGE DIP is a foliage anti-transpirant immersion formula for use in cleaning and shining of cut foliage, evergreens, green and foliage plants.

Prepare a tank mixture of no more than 2% solution of BRANDT SAF-T-FOLIAGE DIP. Add same amount to tank once or twice a week depending on amount of water your foliage crop is absorbing. During your busy season, you might need to recharge your solution daily. If remaining solution is to be sprayed on your crop, be sure the concentration of does not exceed 2%.
